# MINUTES OF MEETING FEBRUARY 20, 2013 PHOENIX, ARIZONA

A public meeting of the Arizona Peace Officer Standards and Training Board was convened on February 20, 2013, at AZ POST, located at 2643 E. University Drive, Phoenix, AZ.

# A. CALL TO ORDER

Chairman Coker called the meeting to order at 10:00 a.m.

#### **B.** Introductions, Presentations and Announcements

Assistant A.G. Diana Stabler stated Executive Director Mann would not be at today's meeting due to his obligations at the Legislature. She also informed the Board that the Strategic Planning Session would be held after the March 20<sup>th</sup> Board Meeting.

### C. Legislative Update

This item was moved to the end of the agenda and taken out of order.

Assistant A.G. Diana Stabler presented several bills and legislative concepts for the Board's discussion. She asked the Board to review the bills and provide direction to Executive Director Mann concerning positions to take on any legislation impacting the Board's authority or duties.

#### **D.** Final Action Cases:

### Case #1 - Stacey P. Grce - Lake Havasu City Police Department

*Ms. Morrison recused herself from this case.* The Board considered comments from Assistant A.G. Nancy Beck and Stacey Grce. Professor Stemley made a motion to adopt the Administrative Law Judge's Findings of Fact and Conclusions of Law, seconded by Chief Kotsur, motion carried unanimously. Mr. Brown made a motion to impose a 6-month suspension of peace officer certification beginning on January 17, 2012, and ending on July 17, 2012, seconded by Professor Stemley, motion carried unanimously.

### Case #2 – Jack D. Mitchell – Maricopa County Attorney's Office

Deputy Director Young and Ms. Morrison recused themselves from this case. The Board considered comments from Assistant A.G. Diana Stabler. Chief Campbell made a motion to adopt the Consent Agreement, Decision and Order for voluntary relinquishment of peace officer certification, seconded by Deputy Nelson, motion carried unanimously.

#### Case #3 – Michael L. Valles – Maricopa County Sheriff's Office

*Detention Director Olson recused himself from this case.* The Board considered comments from Assistant A.G. Diana Stabler. Deputy Director Young made a motion to adopt the Consent Agreement, Decision and Order for voluntary relinquishment of peace officer certification, seconded by Chief Campbell, motion carried unanimously.

*Ms. Morrison recused herself from this case.* The Board considered comments from Assistant A.G. Nancy Beck, Armando Ramirez and his attorney Kathryn Baillie. Deputy Director Young made a motion to adopt the Stipulated Findings of Fact, Conclusions of Law and impose a 2-year suspension of peace officer certification beginning on March 31, 2012, and ending on March 31, 2014, seconded by Chief Kotsur, motion carried unanimously.

# Case #5 - Aaron L. Cowin - Kingman Police Department

The Board considered comments from Program Manager Bob Irish. Chief Kotsur made a motion to adopt the Findings of Fact and Conclusions of Law and revoke peace officer certification, seconded by Deputy Nelson, motion carried unanimously.

# Case #6 - Arnold A. Davis - Phoenix Police Department

*Chief Campbell recused himself from this case.* The Board considered comments from Program Manager Bob Irish. Deputy Nelson made a motion to adopt the Findings of Fact and Conclusions of Law and revoke peace officer certification, seconded by Detention Director Olson, motion carried unanimously.

## Case #7 - Ricardo C. Orosco - Phoenix Police Department

The Board considered comments from Program Manager Bob Irish. Deputy Director Olson made a motion to adopt the Findings of Fact and Conclusions of Law and revoke peace officer certification, seconded by Deputy Nelson, motion carried unanimously.

### Case #8 – Sutton Wohlman – Phoenix Police Department

The Board considered comments from Program Manager Bob Irish and Sutton Wohlman. Chief Campbell made a motion to adopt the Findings of Fact and Conclusions of Law and revoke peace officer certification, seconded by Deputy Nelson, motion carried with two nay votes.

<u>Case #9 – Edrei Cabrera – Salt River Pima-Maricopa Indian Community Police Dept.</u> The Board considered comments from Program Manager Bob Irish. Deputy Nelson made a motion to adopt the Findings of Fact and Conclusions of Law and revoke peace officer certification, seconded by Director Ryan, motion carried unanimously.
