A. CALL TO ORDER

Chairman Coker called the meeting to order at 10:01 a.m.

B. Introductions, Presentations and Announcements

Executive Director Mann introduced Chief Alan Rodbell of the Scottsdale Police Department. Chief Rodbell was appointed to the Board on August 16, 2013. He advised the Board that the academy graduation dates will be included in the Consent Agenda in order to keep Board members informed of upcoming academy graduations. He also informed the Board that Assistant A.G. Diana Stabler will start working a part-time schedule starting in November; in preparation for retirement. She will remain to transition the new Assistant A.G. that will take her place. He also stated he will be out of town for the next two weeks attending the IACP/IADLEST Conference.

C. Petition for Juvenile Indiscretion – Albert O. Seale – AZ Department of Corrections

Director Ryan and Mr. Brown recused themselves from this matter.

The Department of Corrections petitioned the Board to determine that the youthful marijuana use and sale by applicant Albert O. Seale constitutes juvenile indiscretion.

Sheriff Mascher made a motion to determine that Albert O. Seale's high school use and sale of marijuana constitutes juvenile indiscretion and to grant his appointment by the Department of Corrections, seconded by Sergeant Nelson, motion carried unanimously.

D. Final Action Cases:

Case #1 – Illario Talvy – Tombstone Marshal's Office

The Board considered comments from Illario Talvy and Assistant A.G. Nancy Beck. Sheriff Mascher made a motion to uphold the prior ruling of revocation and deny the Motion for Rehearing, seconded by Chief Campbell, motion carried unanimously.

Case #2 – Dwayne Billsie – Navajo Police Department

The Board considered comments from Assistant A.G. Nancy Beck and David Jordan, attorney for Dwayne Billsie. Professor Stemley made a motion to adopt the Administrative Law Judge's Findings of Fact and Conclusions of Law and impose a one year suspension of peace officer certification; beginning on May 14, 2012, and ending on May 14, 2013, seconded by Director Ryan, motion carried unanimously.

Case #3 – Victor M. Lopez Jr. – Cochise County Sheriff’s Office

The Board considered comments from Assistant A.G. Nancy Beck. Mr. Brown made a motion to adopt the Consent Agreement, Decision and Order and suspend peace officer certification for two years; beginning on October 16, 2013, and ending on October 16, 2015, seconded by Chief Campbell, motion carried unanimously.

Case #4 – Kenneth A. Deist – Pinal County Sheriff’s Office

The Board considered comments from Assistant A.G. Diana Stabler and Kenneth Deist. Chief Campbell made a motion to adopt the Findings of Fact and Conclusions of Law and impose a suspension of peace officer certification until lapse, seconded by Sergeant Nelson, motion carried unanimously.

The Board considered comments from Assistant A.G. Diana Stabler. Sergeant Nelson made a motion to adopt the Findings of Fact and Conclusions of Law and revoke peace officer certification, seconded by Professor Stemley, motion carried unanimously.
