MINUTES OF THE MARCH 19, 2025, MEETING OF THE ARIZONA PEACE OFFICER STANDARDS AND TRAINING BOARD PHOENIX, ARIZONA

A. Call to Order

Chairman Dannels called the meeting to order at 10:01 a.m. and asked Colonel Glover to lead everyone in reciting the Pledge of Allegiance.

B. Introductions, Presentations and Announcements

Matt Giordano, Executive Director

- Roll-call was conducted. Eight Board members are present: six attending in person and two are participating via telephone/video conferencing. Mr. Schoch, Commander Figueroa, Professor Robinson, Chief Juarez and Director Thornell are absent.
- Assistant Attorney General Ben Norris is our Independent Legal Advisor for all final action cases.

C. Executive Director's Report

Matt Giordano, Executive Director

- Over the past year and a half, we have been working diligently on updating our rules. Two weeks ago, we held our final meeting with the Governor's Regulatory Review Council (GRRC), during which they approved all of our proposed changes. Some of these changes will take up to six months to take effect. The most significant change pertains to the pre-employment use of marijuana, which will be implemented sometime in September. As a result, starting in September, we will no longer include these petitions in the consent agenda.
- The second week of the Executive Leadership Program will be held next week.
- The Mesa Police Department hosted the Frontline Leadership class last week and this class was extremely successful.
- We held a NextGen Field Training class last week at AZPOST. This training is extremely beneficial as training, hiring and compliance issues continue to change on a regular basis.
- The Basic Training Unit is conducting Active Assailant Instructor Training this week at a local school.
- We continue to assess new physical fitness standards for the academies. As previously mentioned, we are working to replace the POPAT and will provide the Board with additional information as we gather data and evaluate the associated costs.
- We are in the final month of conducting annual training audits. We have conducted 3,000 audits so far. As to date, we have not had any firearms issues brought to our attention.

D. Consent Agenda

Colonel Glover moved to approve the Consent Agenda. The motion was seconded by Chief Deputy Mundell and carried unanimously.

E. Final Action Cases:

1. 2023-152 – Ryun J. Deming – Clarkdale Police Department
The Board heard oral argument on the Administrative Law Judge's (ALJ) Decision dated December 19, 2024, from Assistant Attorney General Joe Dylo, attorney for the Arizona Peace Officer Standards and Training Board. Mr. Dylo recommended that the Board adopt the ALJ Decision as to Findings of Fact and Conclusions of Law with the modifications proposed by the State in its Response to the ALJ Recommended Findings of Fact and Conclusions of Law dated January 23, 2025. Mr. Steven Serbalik, attorney for Mr.

Deming, also addressed the Board. Mr. Serbalik recommended that the Board decline to modify the ALJ Decision and approve it as written. He asked the Board to determine a sanction consistent with the ALJ Decision dated December 19, 2024.

Colonel Glover moved to go into executive session to receive confidential legal advice from the Board's attorney. The motion was seconded by Ms. Weisz and passed unanimously.

The Board entered executive session at 10:35 a.m. and the regular meeting resumed at 11:04 a.m. When the regular meeting resumed, all Board members were still present.

Detective Bro moved to adopt the Findings of Fact and Conclusions of Law in the December 19, 2024, Administrative Law Judge's Decision, without any modifications. The motion was seconded by Colonel Glover and passed with one nay vote recorded for Ms. Weisz.

Discussion ensued regarding discipline. Ms. Weisz asked about prior staff recommendations as to range of discipline for a case similar to this one. Executive Director Giordano stated the rule violation presented by staff was that this was a post-Garrity lie, and believes that the ALJ Decision reflects that POST met its burden of proof. As this is an unprecedented case, the Board will need to determine an appropriate course of disciplinary action.

After additional discussions and deliberations by the Board, Chief Cost moved to close this case with no action. The motion was seconded by Detective Cook and passed with two nay votes recorded for Ms. Weisz and Sheriff Schuster.

2. 2024-075 – Brian Alvarado – Phoenix Police Department

Detective Bro recused herself from this case. The Board considered comments from Assistant Attorney General Joe Dylo, attorney for the Arizona Peace Officer Standards and Training Board, who presented a brief summary of the proposed consent agreement. Ms. Cassidy Bacon, attorney representing Mr. Alvarado, also addressed the Board. Brian Alvarado and Compliance Specialist Mike Deltenre provided statements to the Board as well. After additional discussion, including follow-up questions, Detective Cook moved to approve the proposed consent agreement, imposing a 6-month suspension of Mr. Alvarado's peace officer certification, beginning March 19, 2025, and ending September 19, 2025. The suspension will exclude the 40 hours of suspension time previously served. The motion was seconded by Colonel Glover and passed unanimously.

3. 2024-179 – Orlando R. Ramirez – Gila River Police Department

The Board considered comments from Assistant Attorney General Joe Dylo, attorney for the Arizona Peace Officer Standards and Training Board, who presented a brief summary of the proposed consent agreement. Mr. Chad Smith, attorney representing Mr. Ramirez, was available to answer any questions. Colonel Glover moved to approve the proposed consent agreement, imposing an 18-month suspension of Mr. Ramirez's peace officer certification, beginning June 3, 2024, and ending December 3, 2025. The motion was seconded by Chief Deputy Mundell and passed unanimously.

4. 2024-181 – Ronnie L. Jaques – Surprise Police Department

The Board considered comments from Assistant Attorney General Mark Brachtel, attorney for the Arizona Peace Officer Standards and Training Board, who presented a brief summary of the proposed consent agreement. Mr. Jaques was not present. Detective Cook moved to approve the proposed consent agreement, imposing a 12-month suspension of Mr. Jaques' peace officer certification, beginning July 9, 2024, and ending July 9, 2025. The motion was seconded by Chief Cost and passed unanimously.

5. 2022-229 – Ricardo L. Garcia – Pima County Sheriff's Department

The Board considered comments from Compliance Specialist Michele Blanco, who presented a brief summary of the case. This is a mandatory revocation case. Colonel Glover moved to revoke Mr. Garcia's peace officer certification. The motion was seconded by Detective Bro and passed unanimously.

6. 2024-207 – Brandon J. Bergen – Pinal County Sheriff's Office

Detective Cook recused himself from this case. The Board considered comments from Compliance Specialist William Caldwell, who presented a brief summary of the case. Mr. Bergen was not present. Chief Cost moved to accept the Findings of Fact and Conclusions of Law. The motion was seconded by Chief Deputy Mundell and passed unanimously.

Executive Director Giordano presented the staff's recommendation for disciplinary action, which includes temporary denial of peace officer certification.

Chief Cost moved to accept staff's recommendation to temporarily deny peace officer certification to Mr. Bergen for a period of 24 months, beginning August 12, 2024, and ending August 12, 2026, after which he may be eligible to reapply for certified status. The motion was seconded by Chief Deputy Mundell and passed unanimously.

F. New Charging Cases:1. 2024-224 – Jacob F. Keah-Tigh – Navajo Division of Public Safety

The Board considered comments from Compliance Specialist Michele Blanco, who provided a brief summary of the case. Detective Bro moved to initiate proceedings against Mr. Keah-Tigh's peace officer certification. The motion was seconded by Colonel Glover and passed unanimously.

2. 2024-325 – Manuel Abeyta – Phoenix Police Department

Detective Bro recused herself from this case. The Board considered comments from Compliance Specialist Mike Deltenre, who provided a brief summary of the case. Chief Cost moved to initiate proceedings against Mr. Abeyta's peace officer certification. The motion was seconded by Colonel Glover and passed unanimously.

3. 2024-237 – Christian A. Medrano – Phoenix Police Department

Detective Bro recused herself from this case. The Board considered comments from Compliance Specialist Mike Deltenre, who provided a brief summary of the case. Colonel Glover moved to initiate proceedings to deny peace officer certification to Mr. Medrano. The motion was seconded by Chief Cost and passed unanimously.

4. 2024-246 – Joshua A. McCluskey – AZ Department of Public Safety

Colonel Glover recused himself from this case. The Board considered comments from Compliance Specialist Arlene Heckel, who provided a brief summary of the case. Detective Cook moved to initiate proceedings against Mr. McCluskey's peace officer certification. The motion was seconded by Chief Cost and passed unanimously.
