#### A. CALL TO ORDER

Chairman Coker called the meeting to order at 10:04 a.m.

# B. Executive Session for Legal Advice on Call to the Public and a Personnel Matter: Allegation of Conflict Executive Director

The Board voted to go into Executive Session at 10:04 a.m. to discuss a personnel matter and obtain legal advice from its attorney. The Open Meeting reconvened at 11:05 a.m.

## C. Introductions, Presentations and Announcements

Executive Director Mann informed the Board that a Police Supervision Class was in attendance at today's meeting. He also informed the Board that Bob Irish, Compliance Manager; Don Yennie, Training Manager and Officer Lori Ketron from In-Service Training will all be retiring this month.

## D. Legislative Update

Executive Director Mann stated the legislature adjourned "sine die" on June 14, 2013.

#### E. Proposed 2013/2014 Fiscal Year Budget

Executive Director Mann presented the 2013/2014 fiscal year budget to the Board for its approval. Chief Campbell raised a question regarding the projected FY 14 budget; a discrepancy was noted. The discrepancy was corrected and the budget was presented for approval.

Ms. Berens Weisz made a motion to adopt the proposed 2013/2014 Arizona POST budget at the category level to allow appropriate flexibility for staff, seconded by Professor Stemley, motion carried unanimously.

#### F. Final Action Cases:

The Board considered comments from Assistant A.G. Nancy Beck. Ms. Berens Weisz made a motion to adopt the Consent Agreement, Decision and Order for voluntary relinquishment of peace officer certification, seconded by Professor Stemley, motion carried unanimously.
